#### **Environmental Review:**

The staff has reviewed the proposed activity for compliance with the California Environmental Quality Act (CEQA). Laserfiche is the document management software platform used by the City to securely store and manage documents from every department. Council earlier approved a licensing upgrade for this product that will greatly expand features and staff access to these new capabilities.

The training will update and provide hands-on training for the Community Development Department Administrative Assistant Yolanda Tinajero and the Public Works Department Administrative Assistant Cinthia Ugalde on the Laserfiche Records Management software for city records. The conference offers classes, hands-on lab sessions, and technical training sessions to expand the staff's knowledge of records management and administration features and to gain insights into the latest Laserfiche product innovations, best practices, and helpful techniques of the software.

The cost of the conference, hotel fees, and food per diems will exceed the Expense and Use of Public Resources Policy limits established by City of Wasco Resolution No. 2006-2327, limiting expenses to \$500.00 per trip. As a result, the City Council must approve the travel request as the expenses for the cost of the trip will exceed \$500.00.

#### **Fiscal Impact:**

The cost of this training, including the conference and travel expenses, is estimated to not exceed \$2,000.00 per attendee. The training cost is contained in the adopted FY 2023-2024 Budget; no budget action is required with approval of this item.

- 2) Find that this action is not a project as defined under the California Environmental Quality Act State CEQA Guidelines; therefore, pursuant to State Guidelines Section 15738, no environmental review is required under CEQA.

#### **Environmental Review:**

This action is not a project within the meaning of CEQA Guidelines Section 15378 and is, therefore, not subject to CEQA since it does not have the potential to result in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment. The approval of this agenda item does not commit the City to a definite course of action concerning a project since the action authorized herein may lead to the negotiation of a grant agreement. This proposed activity is, therefore, not subject to CEQA. Any future action connected to this approval that constitutes a project will be reviewed for compliance with CEQA.

#### Background:

The Low Carbon Transit Operations Program (LCTOP) was created to provide operating and capital assistance for transit agencies to reduce Greenhouse Gas (GHG) emissions and improve mobility, with a priority on serving disadvantaged communities (DACs). Per

Public Resource Code 75230 (f) (1-3), monies for the program shall be expended to provide transit operating or capital assistance that meets any of the following:

- 1. Expenditures that directly enhance or expand transit service by supporting new or expanded bus or rail services, new or expanded water-borne transit, or expanded intermodal transit facilities, and may include equipment acquisition, fueling, and maintenance, and other costs to operate those services or facilities.
- 2. Operational expenditures that increase transit mode share.
- 3. Expenditures related to the purchase of zero-emission buses, including electric buses, and the installation of the necessary equipment and infrastructure to operate and support these zero-emission buses.

Caltrans, in coordination with the California Air Resources Board (CARB), will review each project to determine if the project supports at least one of the above-listed criteria, decreases GHG emissions, and benefits low-income households, low-income communities, and/or a DAC (also known as Priority Populations).

The City of Wasco is working on a New Transit Operating and Maintenance Facility Project. The project aims to support the Dial-a-Ride Transit Department by providing the necessary fueling infrastructure for electric, CNG, and gasoline buses. The facility will be situated on the southeast corner of Filburn Street and Central Avenue.

This resolution authorizes the submission of the application for LCTOP funds and the City Manager's execution of the Certifications and Assurances and Authorized Agent forms.

#### Fiscal Impact:

The City of Wasco will have four fiscal years from the project award date to expend funds. For rollover funds, the four years begin with the last rollover year in which funds are accrued.

Lead Agencies **cannot** expend LCTOP funds on costs incurred before LCTOP award/approval. LCTOP is not a reimbursement program; funds are awarded annually upfront for expenses approved and outlined in the Allocation Request to be incurred after the project is awarded.

The City of Wasco must track interest earned on LCTOP funds. Project Activity Reports (PAR) must include interest earned for each project. Interest on LCTOP funds must be used similarly as the principal. Interest remaining after a project has been completed can only be applied to an approved LCTOP project.

#### Recommendation:

Staff recommends the City Council:

- 1) Review and accept the Notice of Completion and acceptance and authorize the City Clerk to file the Notice of Completion; and,
- 2) Find that this Project is classified as categorically exempt pursuant to CEQA Section 21080 (b)(4); 15269(b)(c).

#### **Environmental Review:**

Staff has reviewed the proposed Project for compliance with the California Environmental Quality Act (CEQA) and has determined that the Project is categorically exempt pursuant to CEQA Section 21080 (b)(4); 15269(b)(c), as it is characterized as emergency project due to the nature of the project site. Thus, no environmental review is required.

#### Discussion:

The abatement of asbestos, lead paint and PCB's at the old Labor Camp location on H Street was approved by Council on October 17, 2023 to be awarded to CVE Contracting Group, Inc. in the amount of \$2,597,000. This abatement phase was the first step in the process of getting the site completely cleared since abatement needed to take place prior to demolition.

CVE Started their work on October 30, 2023 with their last day being January 17<sup>th</sup>, 2024. In all, they completed the project within their originally allotted time. Upon completion, Staff contacted the Valley Air Pollution Control District and received their approval of project completion.

As such, Staff recommends filing of a notice of completion for the Project.

#### **Fiscal Impact:**

The City has allotted funds for this Project under Project No. 21003. In total, The budget shows \$9,360,432 coming from the General Fund. The agreement with the High-Speed Rail Authority has authorized reimbursement of up to \$9,000,000 related to the abatement and demolition of this site. The total cost of the Project came at the original bid of \$2,597,000 leaving \$6,403,000 (reimbursable) & \$6,763,432 (budgeted) remaining for the demolition & site clearing phase.



#### Recommendation:

Staff recommends the City Council:

- Adopt a Resolution Authorizing the City Manager to approve the purchase of a rebuild kit for Raw Sewage Pumps from Xylem Water Solutions USA, Inc. for up to \$20,000.00; and
- 2) Find that this action is not a project as defined under the California Environmental Quality Act State CEQA Guidelines; therefore, pursuant to State Guidelines Section 15738, no environmental review is required under CEQA.

#### **Environmental Review:**

Staff has reviewed the proposed activity for compliance with the California Environmental Quality Act (CEQA). It has been determined that the activity is not a "Project" as defined under Section 15378 of the State CEQA guidelines because the proposed activity consists of a governmental fiscal/administrative activity that does not result in a physical change in the environment; therefore, pursuant to Section 15060(c)(3) of the State CEQA Guidelines, the activity is not subject to CEQA. Thus, no environmental review is required.

#### Discussion:

The influent pump station has a critical role in any wastewater treatment facility. It is responsible for collecting all the water that enters the facility and pumping it out of the raw sewage well for treatment. Due to the harsh and corrosive environment that the submersible pumps are exposed to, the pump station experiences regular wear and tear. It is an essential part of the process and requires proper maintenance to ensure its smooth functioning.

It is important to keep spare parts in stock to ensure the treatment process runs smoothly and without disruption. This will allow quick repair or replacement of any faulty pumps and minimize system downtime. By taking these measures, we maintain compliance and ensure that the treatment process operates efficiently.

Staff received a \$16,826.00 spare parts estimate from Xylem Water Solutions USA, Inc., an authorized distributor of Flygt pump parts. The \$20,000.00 request includes a contingency for parts, taxes, and freight charges that are subject to change.

Attachments include the quotation or the parts order and a sole source letter identifying Xylem as the authorized Flygt parts distributor in the region.

#### Fiscal Impact:

The procurement of these parts will be covered under the adopted Wastewater Equipment Repair #30400-50530 budget. No budget action is required with approval of this item.

#### Recommendation:

#### **Environmental Review:**

Staff has reviewed the proposed activity for compliance with the California Environmental Quality Act (CEQA). It has been determined that the activity is not a "Project" as defined under Section 15378 of the State CEQA guidelines because the proposed activity consists of a governmental fiscal/administrative activity that does not result in a physical change in the environment; therefore, pursuant to Section 15060(c)(3) of the State CEQA Guidelines, the activity is not subject to CEQA. Thus, no environmental review is required.

#### Discussion:

This is a request for staff approval for the attendance of Water Supervisor Cesar Montes and Water Operator Raul Gutierrez at the 2024 California Rural Water Association, which will be held from April 22 to April 25, 2024, in South Lake Tahoe. The purpose of this educational expo is to enhance the skills of water system operators. During this 3-day seminar, attendees will receive updates on critical aspects of operating and maintaining a water system, including treatment technologies, regulatory compliance, generator operations, and leak detection.

The cost of attending the conference, which includes hotel fees and per diems for food, will surpass the expense limit of \$500.00 per trip as set by the Expense and Use of Public Resources Policy of the City of Wasco. 



The term "reasonable to meet" is defined: A) Operational Feasibility: The requested improvement must be safe to operate, and there must be adequate roadways for transit vehicles; B) Duplication of Service: The proposed service shall not duplicate other transit services; C) Timing: The proposed service shall be in response to an existing rather than a future need; and D) Service must meet the legally required farebox ratio (PUC Sections 99268.2, 99268.5 and CAC Sections 6633.2, 6633.5) with fares close to fares of similar service."; and,

WHEREAS, a public hearing was duly advertised and held on March 16, 2021, to receive public comments regarding unmet transit needs that are reasonable to meet; and,

**WHEREAS**, the City of Wasco is required to submit findings from the annual unmet transit needs public hearing to Kern COG by the end of April 2021.

### **Environmental Review:**

Staff has reviewed the proposed activity for compliance with the California Environmental Quality Act (CEQA). It has been determined that the activity is not a "Project" as defined under Section 15378 of the State CEQA guidelines because the proposed activity consists of a governmental fiscal/administrative activity that does not result in a physical change in the environment; therefore, pursuant to Section 15060(c)(3) of the State CEQA Guidelines, the activity is not subject to CEQA. Thus, no environmental review is required.

### Discussion:

This is a request for the Mayor's endorsement of a letter supporting the Shafter Wasco Irrigation District's groundwater sustainability efforts, specifically the Dresser and Poplar Recharge Projects. The projects aim to improve the Shafter-Wasco Irrigation District's groundwater recharge capabilities, which will help ensure a more reliable water supply and build drought resiliency in the region. By increasing the groundwater levels in the shared aquifer, we can preserve our city's only source of drinking water.
